ORDER:-

The State Commissioner for the Differently Abled in the letter read above has requested the Government to delegate powers to incur the expenditure not exceeding the amount sanctioned in the Budget Estimate in certain ongoing schemes so as to avoid delay in implementation of Welfare of Differently Abled Persons every year.

2. The Government after careful examination accept the proposal of the State Commissioner for the Differently Abled and accord delegation of powers to State Commissioner for the Differently Abled, to implement the following Schemes of Differently Abled Persons to incur the expenditure within the Budget provision of the respective Head of Account as annexed in this order.

3. The State Commissioner for the Differently Abled is also directed to submit the utilization certificates to Government for every schemes by the end of the every financial year and also requested to ensure the following condition while incurring expenditure:-

- (i.) The expenditures should be restricted to existing rate of assistance and number of beneficiaries, subject to availability of adequate Budget provision
- (ii.) Government sanction should be obtained to increase number of beneficiaries and to revise the rate of assistance.
- (iii.) If, any additional funds required and re-appropriation made, orders should be obtained from Government.
- (iv.) Tamil Nadu Transparency Tenders Act 1998 and Rules 2000 should be followed scrupulously in procurement schemes,
- (v.) To decide the continuance of the scheme based on the necessity and performance report.
- (vi.) The Grants to Non Governmental Organization's have to be released on quarterly basis, based on the Government Guidelines, number of beneficiaries, actual expenditures, financial position of the Non Governmental Organization, Inspection Report etc.,

4. The Government direct that this order come to effect from the financial year 2018-2019.

5. This order issues with the concurrence of Finance department vide its U.O. No.21860/US(Gr)/2018, dated 02.05.2018.
